

MEMORANDUM OF UNDERSTANDING ESTABLISHING A TRANSFER PATHWAY BETWEEN SOWELA TECHNICAL COMMUNITY COLLEGE AND

UNIVERSITY OF LOUISIANA AT LAFAYETTE

This Memorandum of Understanding ("MOU") made and entered into effective the 11th day of July, 2018 ("Effective Date"), serves as an agreement between SOWELA TECHNICAL COMMUNITY COLLEGE ("SOWELA") and UNIVERSITY OF LOUISIANA AT LAFAYETTE ("UL Lafayette") to facilitate transfer of students desiring to earn a Bachelor of Science in Nursing degree ("RN to BSN Program") at UL Lafayette upon completion of their Associate of Science in Nursing degree ("ASN Program") at SOWELA.

A. <u>Transfer Requirements</u>. SOWELA students in the ASN Program who express interest in enrolling in the RN to BSN Program at UL Lafayette must meet the following transfer requirements:

- 1. SOWELA students shall only be admitted to the RN to BSN Program at UL Lafayette upon completion of all degree requirements for SOWELA's ASN;
- SOWELA students must meet all UL Lafayette's admission requirements prior to enrolling in the RN to BSN Program courses at UL Lafayette, which includes (i) a minimum GPA of 2.5, (ii) obtaining a passing score on the NCLEX-RN licensure exam, and (iii) obtaining an active, unencumbered RN nursing license; and
- 3. Upon admittance, SOWELA students admitted to the UL Lafayette RN to BSN Program must use the catalog of record and be assigned an advisor at UL Lafayette for assistance, in accordance with policies of UL Lafayette's College of Nursing and Allied Health Professions.

B. UL Lafayette Responsibilities. UL Lafayette shall:

- 1. Deliver curriculum information to SOWELA faculty and students regarding its RN to BSN Program;
- Provide UL Lafayette advisors to participating SOWELA students in the ASN Program. Advisors will be available by telephone and email, as well as for on-site appointments at the UL Lafayette campus;
- 3. Communicate any and all RN to BSN Program changes to SOWELA in a timely manner;
- 4. Encourage SOWELA students in the ASN Program to become engaged in activities and/or events held by UL Lafayette; and
- 5. Provide documentation to SOWELA regarding the transferability of the ASN Program's credits to UL Lafayette's RN to BSN Program, which is incorporated herein and attached hereto as Exhibit A.

C. SOWELA Responsibilities. SOWELA shall:

- 1. Maintain academic files related to the progression of students that transfer to UL Lafayette pursuant to this MOU;
- 2. Encourage SOWELA students to pursue the transfer pathway to UL Lafayette, and advise students to progress in their coursework in a timely manner;
- With the consent of the SOWELA transferring students, provide UL Lafayette the transcripts of the students, in order to facilitate the recording of student data at UL Lafayette and to allow for timely transfer and advising;
- 4. Communicate changes in the ASN Program to UL Lafayette in a timely manner;
- 5. Promote and market the UL Lafayette RN to BSN Program in the Lake Charles, Oakdale, and surrounding areas;
- 6. Coordinate the participation of students in SOWELA's ASN Program in UL Lafayette activities and/or events sponsored by the College of Nursing and Allied Health Professions; and
- 7. Maintain the ASN Program's active and full accreditation by Accreditation Commission for Education in Nursing ("ACEN").

E. Additional Terms.

- 1. The term of this MOU is for a period of five (5) years, commencing on Effective Date. This MOU may be renewed after completion of the initial five (5) year term for a five (5) year renewal term only upon the written notice signed by the parties hereto.
- Either party may terminate the MOU at any time without cause by giving written notice no later than at the end of the semester of the notification. In the event this MOU is terminated, students who have declared their intent to participate in the RN to BSN Program will be allowed to progress through the curriculum and complete the RN to BSN Program according to the terms of this MOU.
- 3. Any alteration, variation, modification, or waiver of provisions of this Agreement shall be valid only when it has been reduced to writing and executed by all parties hereto.
- 4. This MOU shall be reviewed annually, and both parties will share assessment data and meet periodically to assess the transfer pathway.
- 5. This MOU may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
