The Director oversees a staff of area coordinators, community hall directors and community assistants in the design and implementation of a comprehensive residence education program, including setting goals, metrics and learning outcomes that are reviewed and measured on an on-going basis. The Director must have a thorough knowledge of best practices and must convey a passion for student engagement and development that enhances opportunities for students to succeed academically and socially. The Director is a department head in the Division of Student Affairs reporting directly to the Dean of Students.

Essential Functions:

Develop and manage the delivery of a comprehensive residence life program where learning outcomes are developed and assessed based on a clearly articulated vision and revised based on assessment outcomes; select, train and supervise a team of professional and student staff; respond to campus conduct issues and critical incidents; develop residence life handbooks and publications; maintain collaborative partnerships with the Office of First Year Experience, Student Engagement and Leadership and other University partners to enhance student happiness and success; serve on University committees and task-forces; maintain professional associations; participate in student and parent orientations; meet with students and families on a daily basis; maintain visibility in the halls and communities; work evenings and weekends during programming events and activities; perform other duties as assigned by the Dean of Students.

The candidate must have a minimum of 5 years colligate residential life experience in setting learning outcomes, creating programs, and assessing and revising programs based on the learning outcomes.
