The University Student Discipline Appeals Committee met Tuesday, May 14, 2019, at 3:20PM in Room 163 of the Student Union to hear the following appeal:

CASE #358: A sophomore majoring in Biology from Baton Rouge, LA.

You was appealing a charge against the Code of Student Conduct for Academic Dishonesty (Plagiarism) imposed by the Office of Student Rights and Responsibilities for conduct identified by your ENGL206 instructor, Dr. E. Laurel Ryan, that occurred during the Spring 2019 semester. The instructor assigned a "zero" on the written assignment at issue per the course syllabus based upon her review of the work. Additional discipline sought by the Office of Student Rights and Responsibilities in a Letter of Agreement dated April 26, 2019 was: 1) disciplinary probation for a period of one year expiring 26 April 2019, and 2) mandatory sessions for Decision Making with the Office of Counseling and Testing to be completed by 30 June 2019.

The instructor was not able to be present for the proceedings, but the Committee heard your oral testimony and reviewed all written materials provided by both sides regarding the work at issue, as well as the University Code of Conduct regarding Academic Conduct and Dishonesty. Written materials included, among other items: the Academic Honesty Report filed by the instructor 4/10/19, the course syllabus, hardcopy of the work you submitted and one allegedly plagiarized source as provided by the instructor, and email correspondence between yourself and the instructor.

The Undergraduate and Graduate Academic Catalogs, the Code of Conduct, and the Academic Honesty Policy of the University all read, in relevant part:

"Plagiarism is a specific type of cheating. It occurs when a student claims originality for the ideas or words of another person, when the student presents as a new and original idea or product anything which in fact is derived from an existing work, or when the student makes use of any work or production already created by someone else without giving credit to the source. In short, plagiarism is the use of unacknowledged materials in the preparation of assignments."

Upon deliberation, the Committee unanimously <u>voted to GRANT your appeal</u>, and vacate the Letter of Agreement of April 26. The Committee determined citations in the work to be poorly executed, but without intent to improperly acknowledge source material or claim ideas or words as your own, such that a formal charge of plagiarism as strictly defined was not supported. The Committee encourages the instructor to afford you an opportunity to avail yourself of available re-write credit provided under the class policies described in the course syllabus to address the concerns of the instructor identified in the assignment at issue. The Committee also encourages you to use the free resources of the Writing Center in Griffin Hall 107 to help you to avoid potential issues with academic honesty in the future.
