Instructional Technology Advisory Council (ITAC)

Charter:

The Instructional Technology Advisory Council (ITAC) is comprised of representatives from various Colleges, Departments and Organizations throughout the University who are involved in technology-mediated teaching and learning. The Council meets monthly to discuss instructional technology initiatives, best practices for using teaching tools, and emerging pedagogical trends in higher education. This group will advise the Provost and CIO on defining and managing classroom and laboratory technology standards, prioritizing instructional technology projects/initiatives, and recommending/developing new pedagogies that fully utilize technology to enhance the educational experience and increase learning outcomes of our students. In addition, the Council will:

- Assist in the development, evolution, and support of SMART Classroom and Computer Lab standards (both open-use STEP and departmental labs in terms of software, hardware, application, etc.);
- Align technology investments, planning, integration, and priorities with endorsed teaching and learning pedagogies, standards, etc.;
- Align Technology Council recommendations, advice, and recommended investments with other governance and advisory groups on campus;
- Explore new technology alternatives available in delivering University instructional services;
- Recommend, review, and develop professional development programs/services for faculty and staff to better utilize and integrate technology across the curriculum;
- Facilitate and advocate a sustainable, continual investment in technology and insure that the academic enterprise makes systemic and systematic investments in instructional technology resources;
- Insure that instructional technology on campus has the capability and capacity to meet our needs today and into the immediate future;
- Provide guidance, leadership, and governance in managing, maintaining, and expanding the University's learning management system;
- Develop an annual continuous service improvement plan
