§3217. University of Louisiana System

- (3) McNeese State University at Lake Charles.
- (4) Nicholls State University at Thibodaux.
- (5) Northwestern State University of Louisiana at Natchitoches.
- (6) Southeastern Louisiana University at Hammond.
- (7) The University of Louisiana at Lafayette.
- (8) The University of Louisiana at Monroe.
- (9) The University of New Orleans.
- (10) Any other college, university, school, institution or program now or hereafter under the supervision and management of the Board of Supervisors for the University of Louisiana System.
