By cultivating research, creative, and professional excellence, the Graduate School at the University of Louisiana at Lafayette champions the intellectual mission of our University through the pursuit of scholarly integrity, inclusivity, and community in graduate studies. The Graduate School, guided by the values of a student-focused, doctoral-granting, higher research public university, provides the academic and administrative leadership for distinct and diverse graduate students and graduate programs to thrive and to grow.

The Graduate School at UL Lafayette administers 11 doctoral degree programs, master's degree programs in 33 disciplinary areas, and graduate certificate programs in 8 areas as well as the Master's +30 program and other non-degree opportunities for pursuing graduate studies. The Graduate School has an enrollment of 2,050 (Fall 2018) and

represents near 12% of the total enrollment of 17,123 at the University. The Graduate School operates with 10 full-time staff members, 8 graduate assistants, 3 undergraduate scholarship workers, and the Dean.

Graduate programs approved since 2014: PhD Earth and Energy Sciences; MAT Elementary and Elementary French Immersion; MS Informatics; MS Environmental Resource Science; Graduate Certificates in Business Administration, Cardiovascular Nursing, Instructional Coach, and Professional Writing; MBA (online delivery); MS Computer Science (online delivery).

Most recent key accomplishments and initiatives to better serve applicants, graduate students, and graduate programs include: proposal of 18 competitive BORSF Endowed Superior Graduate Student Scholarships (including gifts of \$60k each, with \$40k BORSF match secured for 11 scholarships thus far); increase to graduate assistant minimum stipend levels from a doctoral stipend level of \$12,000 to \$15,900 and a master's stipend level of \$7,500 to \$10,070; creation of the University Committee for Graduate Student Success and Retention; creation of the James Jackson Community of Scholars, an organization to support underrepresented and diverse graduate students created in partnership with the Office for Campus Diversity; implementation of the Banner admissions segment (including two new application systems with admissions serving as the first "go-live" in the University's planned four-year Banner implementation); implementation of two CRMs (Banner Recruit CRM and Hobsons Connect CRM); implementation of OnBase as a technology-driven solution to improve graduate recruitment and admissions via the digitization (and electronic sharing) of applicant/student files; creation of the university-wide UL Lafayette Alumni Association Outstanding Master's Graduate Award; introduction of the Dissertation Bootcamp and Shut-Up and Write events to better support graduate student writing and completion; introduction of a university-wide 3MT competition; teaching and mentoring workshops in partnership with the Office of Academic Affairs, the Office for Campus Diversity, and the Office of First Year Experience.

Key accomplishments as Interim Dean included: leadership of the University Task Force on Graduate Education Governance and presentation of its final report to the graduate faculty and provost; stabilization, reallocation, and growth of the Graduate School staff; increased and improved communication with graduate coordinators, department heads, and academic deans; procurement of funds to provide a 50% health insurance premium assistance for international graduate assistants and fellows; successful negotiation of earlier approval of the graduate assistantship and fellowship budgets; institution of a more uniform and efficient procedure for appointment of graduate assistants; implementation of Acalog for delivery and management of the catalog; transition to an electronic submission and review process for graduate faculty applications; reconstitution of the Graduate Dean's Student Advisory Council; and implementation of enhanced programming for graduate students with re-envisioned and revitalized new-student orientation, professional development programming, and Graduate Student Appreciation Week events/recognitions.

Provided leadership in the administration of the M.A. graduate degree program in History with concentrations in European, Latin American, Public, and U.S. history. Program grew during this time from an enrollment low of 14 graduate students to 29 graduate students in FA2011; enrollment following remained steady at around 30 graduate students until recent years. Graduate students include both full- and part-time students and, in these years, began to include significantly more students from outside of Louisiana than in years past. Our students typically follow three different career paths: they go on to pursue the Ph.D., teaching careers at the secondary level, and/or Public History professions in archives, museums, etc. The program was averaging an annual graduation rate of some 7 M.A. graduates and, as my last recruited students were completing the program, had increased to 9-13 graduates annually (2011-2013). Additionally, during my time as graduate coordinator the Department developed and secured UL System and Louisiana Board of Regents approval to offer, in partnership with the School of Architecture and the Department of Sociology, Anthropology, and Child and Family Studies, an interdisciplinary Graduate Certificate program in Historic Preservation.
