Additionally, the department will create and send marketing emails to persons who have requested information, current participants, past participants that exist in our registration system. Our registration system allows us to access registration data and analyze on annual basis. By achieving our goals of increasing enrollment and new course offerings, we expect to generate increased revenue. Enrollment and course data are discussed in weekly operation and programming staff meetings.

With new course development in mind, we evaluated the workload of our staff - specifically those that were tasked with developing new courses. In the early stage of the 17-18 assessment cycle, we restructured operations by removing day-to-day administrative duties from staff that were responsible for programming. This allowed them to focus their time on the production of new courses. In doing this, the result yielded a higher percentage of new courses overall annually. The sum of percentages of new course offerings for this 17-18 cycle was 10% more than the previous 16-17 cycle.

The process of comparing percentages of new course offerings each year has given our programming staff a target to shoot for each semester. It has helped to spawn a new program series, "SPICE" (Seniors Participating in Continuing Education), in which we hope to develop and grow in the next assessment cycle. This new program area will afford many opportunities for new courses thus helping us to continuously achieve our goal of reaching more persons in the community. We think that if SPICE is developed with high quality, it will increase our participant repeat rate and equally increase open enrollment registrations.
