#### **Internships**

##### **Nursing:**

Undergraduate and graduate nursing curricula require extensive clinical rotations within the course of each program. Undergraduate nursing students engage in direct patient care as they acquire the necessary knowledge, skills and abilities needed for entry level practice. On the master's level, graduate students engage in various advanced practice and educational settings to prepare for the roles of nurse educator and nurse practitioner. Students enrolled in the Doctor of Nursing Practice program complete a minimum number of residency hours as a requirement for the completion of the synthesis project, a requirement for degree completion.

##### **HIM:**

Description of HIM 482, Management Internship: The HIM seniors complete 160 hours of management internship during the spring semester before graduation. They are placed at internship sites such as hospitals, physicians' offices, healthcare billing companies, foundations, government health agencies, and other healthcare-related sites. The students complete multiple projects throughout their internship. These projects are determined by the supervisor within each facility and offer a wide variety of experiences and opportunities for the students.

##### **Health Services Administration:**

Description of HSA 409, Capstone Seminar: The HSA students complete 192 hours of internship during the spring semester before they graduate. They are placed at internship sites such as

hospitals, physician offices, healthcare billing companies, foundations, among many others. They will complete multiple projects throughout their internship. Students and their internship supervisors choose projects together that fit the needs of their organization. Projects consist of patient satisfaction surveys, reward and recognition programs, employee training manuals, patient brochures, utilization review outcomes among others.
