The students will learn about the specific management and other related business concerns and issues unique to the healthcare field and understand the real world working environment of a major healthcare institution or setting.

Related Measures

M 1: Internship

This goal is accomplished in part by requiring all MBA/HCA students to participate in two internships in a major healthcare setting. Whether the goal is accomplished is assessed by requiring the student's preceptor (supervisor) to evaluate the student's performance in carrying out the project goals of the internship. The preceptor is the student's immediate supervisor within the healthcare institution in which the internship is carried out and is an independent evaluator of the student's performance. The preceptor is required to answer nine specific questions concerning the student's performance, knowledge and fitness to manage in the healthcare field. (The MBA/HCA students also take IBUS 540 and MGMT 590 in which two goals of the entire program are assessed.) The student must submit a very detailed report on the internship which is reviewed and evaluated by the MBA director. This allows for a second assessor of the students knowledge and understanding of the unique management issues presented in a healthcare setting. This ensures the reliability and validity of the assessment process. In addition the students are also required to evaluate their preparation for the internship. The questions use to evaluate the students performance is as follows:
