# **Mission / Purpose**

The Ronald E. McNair Post Baccalaureate Achievement Program is designed to provide preparation for graduate study leading to the Ph. D. to eligible students who are from low income/first generation backgrounds and students who are from groups underrepresented in graduate study (Native American, Hispanic/Latino, African American, Pacific Islanders, Alaskan Natives). Participants are provided with the opportunity for a faculty-mentored research internships, seminars and workshops on graduate school admissions, testing, financial aid, travel to conferences and other experiences to assist them for enrollment in graduate study. This program was first funded in 1992 and has continuously been refunded through competitive grant competitions through the U.S. Department of Education. We are currently in the 3rd year of a five year funding cycle.

The McNair Program assists the university's mission of retaining, preparing and graduating individuals with academic backgrounds and skills necessary to enter the workforce and/or pursue graduate study or professional school matriculation.

## **SLO 1: Completion of Scholarly Activities**

60% of the McNair participants served during each budget period will complete research and scholarly activities that will directly impact their educational progression as measured by completion of a research internship, public research presentation, and/or submission of an approved final document.

Participants will (a) be matched with a faculty mentor for a research internship wherein they will undertake an investigative study that will prepare them with scholarly skills necessary for graduate/doctoral study; (b) publicly present their research at a campus gathering and/or conference; and/or (c) submit a final, approved research document to the McNair office.

Number of students assessed = 24 (77% of 31). Twenty-four (24) or seventy-seven per cent (77%) of the thirty-one (31) McNair participants were

matched with a faculty mentor and conducted a research investigative project, presented their research in a public forum, and/or submitted a final, approved document to the McNair office. This percentage exceeded the U S Department of

Education requirements for objective 1.

#### **Post Baccalaureate Program Enrollment**

The program staff with the help of faculty mentors will intensify the efforts expended in generating an increase in students applying and enrolling in graduate school in the academic year following their graduation. This will include additional seminar or workshop sessions on the graduate school process, additional preparation for graduate testing, exploration of additional graduate schools for possible acceptance and additional opportunities for graduate school visitations where possible.

80% of new participants served in each program year will attain a baccalaureate degree within three (3) years of their tenure in the program.

## M 2: Academic Improvement

Participants will improve academically in the area of retention as measured by appropriate course selection per degree requirements, exhibit consistency in class attendance, improve in stability and/or improvement in semester grades, and complete all degree requirements during their tenure in the McNair Program. Individual records, counseling/advising session reports, semester grades, and other pertinent documents will be on file. 100% of eligible participants in targeted cohort will graduate within a three (3) year tenure period.

40% of bachelor degree recipients will enroll in a post baccalaureate program by the fall term of the academic year immediately following completion of that degree.

Graduating participants (those eligible for program admission immediately after graduation) will complete the steps necessary for consideration for admission to graduate schools: (a) search/location for schools with desired degree programs; (b) taking the required graduate test; (c) submission of admission application and 2 funding requests; (d) school visitation if possible; and (e) confirming decisions regarding acceptance of admission and funding award(s). 40% will enroll.

# **Finding (2015-2016) - Target: Met**

2015-2016

24 McNair participants graduated during the program year. Of this number fourteen (14) applied for admission to a graduate program or professional school. Eleven (11) were accepted for enrollment and nine (9) subsequently enrolled. Most of these students received incentives (tuition waivers, assistships, fellowships, etc.) as supportive funding for their studies.

# **Analysis Questions and Analysis Answers**

#### How were assessment results shared and evaluated within the unit?

The results of measures assessment were tabulated and shared in report form to McNair Staff and ultimately in the Annual Performance Report data submitted to the director of Special Services and prepared for SPAC review before uploading to the Department of Education. The report was analyzed, corrected where necessary and then cleared and passed all electronic checks by the Department of Education for its receipt.

There were no action plans created in previous cycle to be implemented. Program operations continued as designed according to the plan of operation and all identified objectives (process and outcome). This describes the manner by which the McNair Program conducts its activities and implementation. As a result of following designed protocols, the 2015-2016 program year has been successful in achieving desired outcomes.

# What has the unit learned from the current assessment cycle? What is working well, and what is working less well in achieving desired outcomes?

During the current assessment cycle we discovered a systematic way of checking our report of data by cross referencing data inputs with record documents, activity listings, input from scholars and mentors, ISIS record checks and data from financial aid and the registrar's office. This provided us with data analysis that resulted in accurate information for reporting. This provided for a more systematic way of dealing with and reporting outcomes in a clear cut appropriate manner.
