Quick Facts Sheet Highlights

- CFS this year were reported at 22,888, in 2016 calls for serviced received reported at 22,892
- Officer initiated calls (foot/area/building patrols) made up 78% of all Calls for Service for 2017.
- UCR data reflects a reduction in crime campus wide in the following categories:  
Robbery, Assaults, Larceny, Arrest, and arrest under 18  
Assaults reported decreased by 19% from 2016 (32 to 26)  
Larcenies reported decreased by 12% from 2016 (193 to 169)  
ULPD experienced an 8% decrease in Arrest: 161 arrest in 2016 to 153 arrest in 2017  
ULPD experienced an 25% decrease in Arrest under 18: 20 arrest in 2016 to 15 arrest in 2017

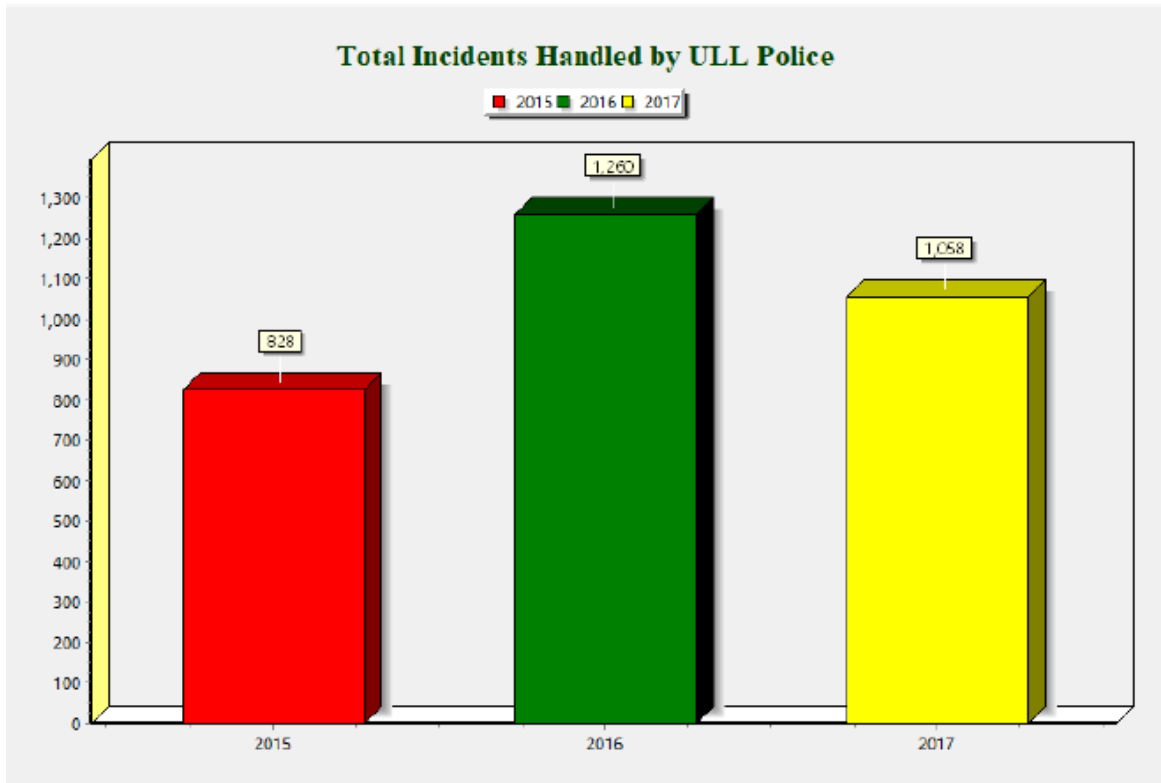

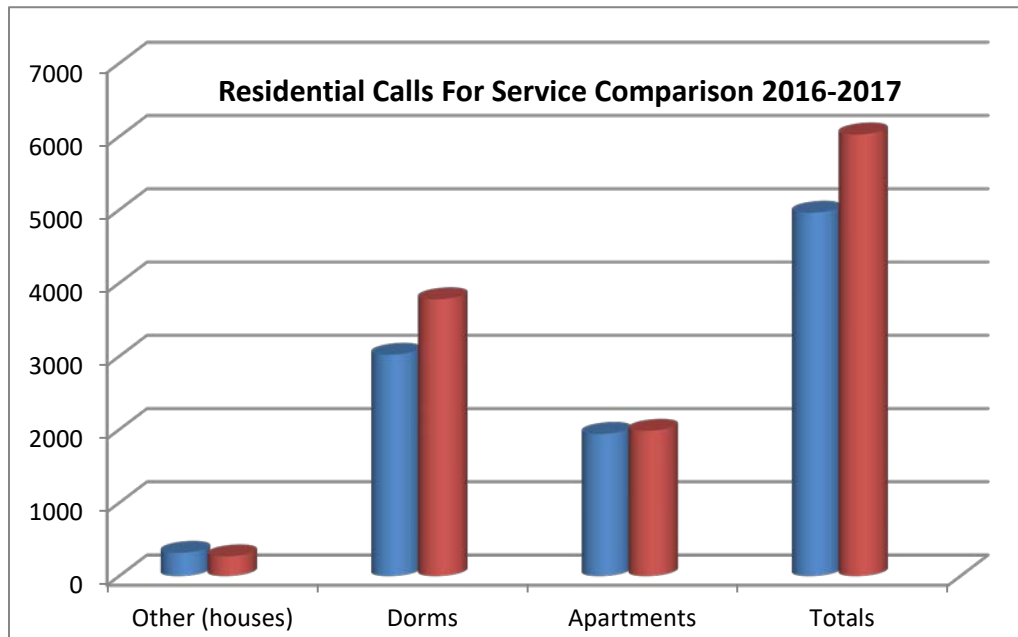

**RESIDENTIAL CALLS FOR SERVICE COMPARISON 2016-2017**



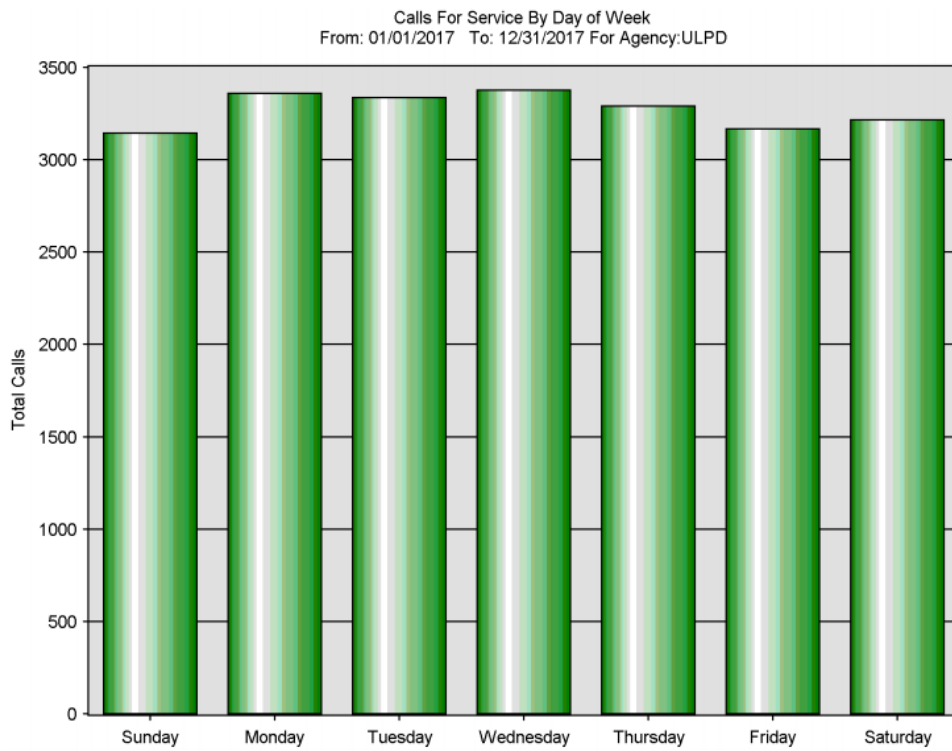

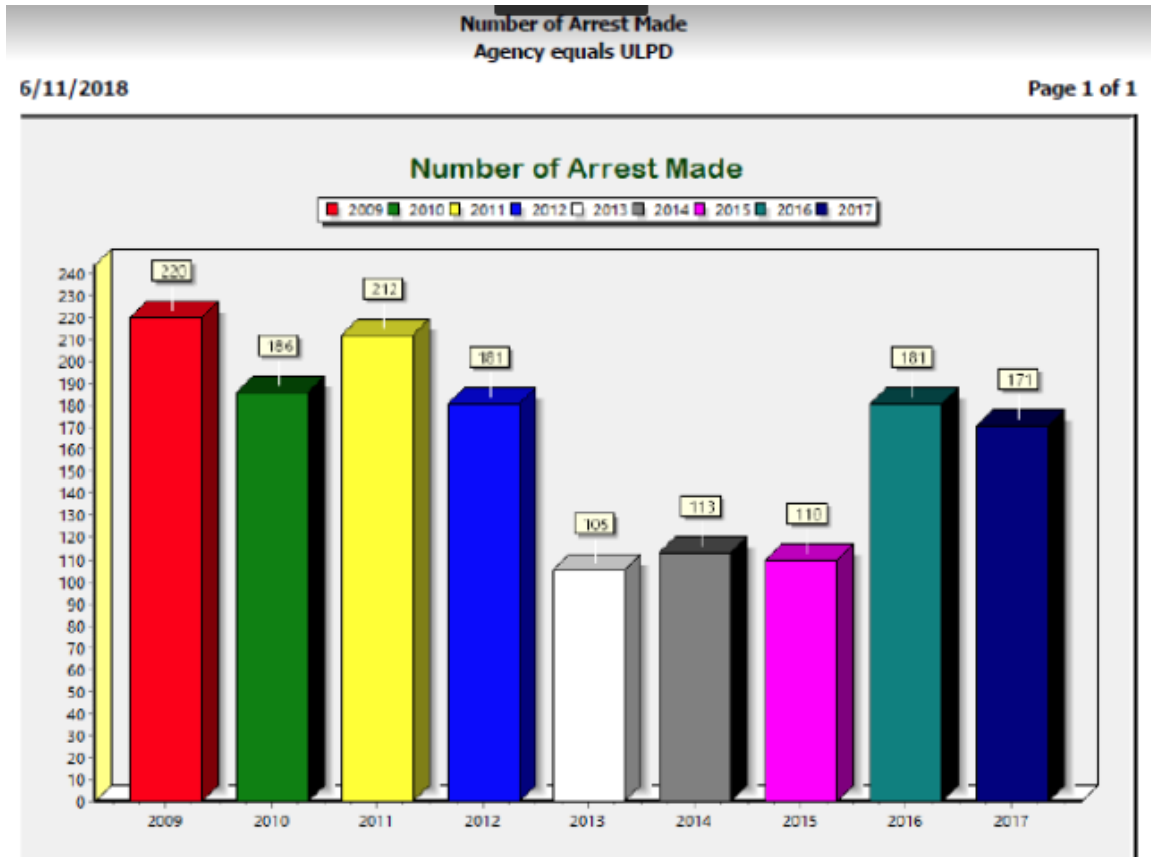


During 2017 the University experienced an increase by 24% burglaries compared to 2016 (34 to 42) although there has been an increase in foot, building, and area patrols during the evening hours throughout campus.

The University also experienced a 25% increase in drug law violations in 2017(34 from 27) compared to 2016. Marijuana remains the primary drug of choice utilized by offenders.

- Total Incidents for 2017 = 1,058 which is a 16% decline in incidents from 2016 = 1,260
- Of the 1,058 incidents there were 171 arrest made by ULPD in 2017
- Based on UCR-Reports arrest are classified as follows:

  - 153 Over 18 Arrest
  - 015 Juvenile Arrest
  - 003 Non-Reportable Arrest
- Of the 171 Arrest made 76 were ULL Students (44%)
- Of the 76 students arrested in 2017, 48 were issued a summons

### **City University Safety Program (CUSP)**

#### **Mission Statement:**

The University of Louisiana at Lafayette Police Department, in partnership with both the Lafayette City Police Department and Lafayette Parish Sheriff's Office are to provide a safe environment for the students within the University District and to educate the university community on safety and security measures. The aforementioned agencies will work collaboratively to strategically address shared crime problems and disorder issues in the multi-agency task force.

This program is in part supported by the UL Lafayette SGA. The success of the program is exemplified by the Lafayette Police Departments' decision to add an additional officer for 2014 (October 2014) and has requested the University do the same (supervisor) to bring the CUSP program to a six (6) person team. ULPD added a Supervisor in 2016. The additional Lafayette Police Officer did not occur in 2016. This objective remains on the 2017 list.

**3-3-17** Officers assisted with clearing the Downtown night club crowds at the 2AM closing time.

**3-4-17** Located suspect in reference to a Hit and Run for Lt. Stelly. Assisted with clearing the Downtown area night club crowds at 2AM.

**3-7-17** Officers conducted unmarked patrol and also surveillance at an apartment located at 801 General Mouton. Officers also arrested a subject with two warrants while responding to a disturbance call on Stevenson Street.

**3-8-17** Officers conducted unmarked patrol and also surveillance at an apartment located at 801 General Mouton in reference to drug activity.

**3-16-17** Officers made an arrest while patrolling Freetown in an unmarked vehicle. The arrest was possession of crystal meth and Xanax.

**4-4-17** Assisted LPSO Intelligence Section with transporting a suspect with an active warrant.

**4-6-17** Officers passed out sexual assault awareness flyers to apartment complexes. The Edge (2), Bridgeway Apartments (2), Campus Crossing (2), University House (2), Canterbury Square (2). Letter of no trespass issued to UL Student, Ashley Washington (B/F DOB 1-11-97), banned from Campus Crossings Apartment Complex.

**4-10-17** Officers investigated 3 or 4 illegal drug activity complaints from Management of the Cottage Landing Apartments at 301 Coolidge Dr. The majority of residents at the target



apartments were not home at the time but a verbal warning was given and no drugs were located.

**4-19-17** Officers conducted a surveillance operation with the assistance of LPD CSU unit at 501 Stewart St. Much of the shift was dedicated to preparing for the operation.

**4-20-17** Officers assisted management of Bisbano's Pizza Parlor in shutting down a 966 related party.

**4-25-17** Officers assisted LPSO in apprehending a warrant suspect. Officers then arrested 13 UL Football players with the assistance of the UL Football Coaching staff.

**4-28-17** Officers assisted with 2 funeral escorts between calls.

**5-2-17** CUSP Officers met with Metro for three individual cases. CUSP made contact with Lafayette Park Police Supervisor Kenneth Franques in reference to future Operations in there are for assistance from them.

**5-8-17** Officers interviewed informant during the beginning of the shift and completed ops plan paperwork for upcoming operation.

**5-23-17** 4 Sexual Assault flyers were given at Campus Edge Apartments, 6 at Bridgeway Apartments, 4 at University Place Apartments and 2 at Cottage Landing Apartments.

**6-5-17** Officers located and arrested two suspects in reference to unlawful entry into an inhabited dwelling ref LPSO CR# 17-0164752. We continued to investigate this incident and identified a third suspect.

**6-6-17** Officers located a suspect of Simple Battery and Criminal Damage to Property ref ULPD case 17-009546. Subject was arrested and released on a summons. Officers secured a third warrant ref LPSO CR 17-0164752.

**6-27-17** CUSP Officers assisted patrol on arresting a subject with felony burglary warrants.

**6-28-17** CUSP Officers caught a shoplifting suspect and assisted in arresting a suspect attempting to run over a LPD Officers. Officers attended LPSO CSU meeting at 0830 hours.

**7-8-17** Officers arrested suspect at Bayou Shadows Apartments for remaining after forbidden in reference to a ULPD case.

**7-11-17** Officers located 1.4G of Marijuana on a traffic stop. Driver was released on a summons.

**7-17-17** Officers completed warrant reference to LPSO case for domestic abuse battery. Much of the morning was spent on this due to attempting to locate on duty judge.

**7-27-17** Officers ran radar on Cajundome Blvd area. Three subjects were stopped for speeding and given warnings.

**7-31-17** At 2230 hours, Deputy Shelby Lafitte rode with Officer Tyler Howerton in an unmarked LPD unit in order to deter and detect criminal activity within the CUSP area of patrols.

**8-1-17** At 2113 hours, Deputy Shelby Lafitte rode with Officer Tyler Howerton in an unmarked LPD unit in order to deter and detect criminal activity within the CUSP area of patrols.

**8-8-17** Officers investigated a drug complaint at Campus Crossing Apartments. A constant search of the apartment yielded a total of 13 grams of "high grade" Marijuana from a resident and a guest. Both suspects were released on misdemeanor summons.

**8-22-17**

CUSP made contact with Bridgeway Apartments manager Kishment who informed us of apartment 4113 and 4114 that are having issues with the smell of burnt marijuana. We attempted to make contact with surrounding apartments, but no one answered. A few days ago, Kishment contacted me via telephone and informed me of a suspicious package while CUSP was not working. I informed her to contact LPD K9 to have the package smelled. I was contacted later by Kishment informing that the K9 alerted on the package and 4 pounds of marijuana from California was recovered by Lafayette Sheriff's Metro agent Jason Kent.

CUSP made contact with Campus Crossing manager Brandon in reference to an incident that occurred when CUSP arrested two individuals with a combined weight of 13 grams of marijuana. We received the name of the possible drug dealer to the two individuals that were arrested. It should be noted that Brandon is a new manager due to the fact that the old manager accepted a higher position. It is said that Campus Crossing contained about 50-60 percent UL Student. Brandon complained about the large amount marijuana complaints that he is receiving from his residents.

CUSP conducted a traffic stop at Macon Road and Eraste Landry Road. After further investigation, the driver was issued a citation for a stop sign violation and no insurance. The vehicle was not towed due to the driver having an infant in the vehicle in route to a doctor's appointment with proof and had no one to pick her up. A NOV sticker was placed on the vehicle and she was given instructions.
