GROWING UP ACROSS THE STREET FROM THE UNIVERSITY, John Tolson III played in Cypress Swamp and attended Hamilton Elementary School. He majored in pre-medicine at UL Lafayette (USL), later graduating from LSU Medical School. Dr. Tolson returned home to establish his family and medical practice. He subsequently offered his time to the institution he credits with laying the groundwork for his success. Now an Emeritus member of its Board of Trustees, during his tenure as chairman

from 1985-1987 the Foundation established an investment policy to manage \$8 million in assets. He is pleased at the growth of those assets, valued at over \$160 million today, as well as the progress of the Foundation and the University. Dr. John Tolson III embodies a lifelong relationship many alumni have with the University – evolving from graduate, to volunteer, to benefactor. The scholarship endowed in memory of his parents completes the circle, and perhaps, gives him the most joy.

The Bella Nickerson Chappuis Endowed Scholarship supports students from Lafayette Parish majoring in Secondary Education.

AS 27-YEAR-OLD JOHN CAMERON NICKERSON

helped Dr. Edwin Stephens plant oak trees on the grounds of a budding university in 1901, he also established roots for a legacy of family service to the institution. His daughter, Bella Nickerson Chappuis Abramson ('37), was the 1935 Camellia Queen and served as secretary to the Dean of Men upon graduation. After World War II, her home and family established, Bella embarked upon a lifetime of support for the University that included service on the Foundation Board

of Trustees from 1983-1993 and University Arts Center Committee. She was an advocate of Dupré Library, the Foundation Honor Roll and Distinguished Professor Awards, as well as a spirited supporter of Ragin' Cajuns® Athletics. The Education scholarship she established bears testament to her patronage. Following his mother's precedent, John Chappuis served as both Foundation board trustee and chairman from 2007-2009; his sister, Cherie

Chappuis Kraft, is a current board trustee. The siblings endowed the Bella Nickerson Chappuis Abramson Professorship in Cinematic Arts.

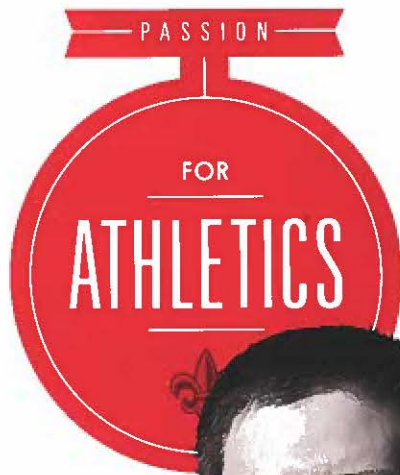


BELLA NICKERSON CHAPPUIS ABRAMSON - 1937
