Chief Academic Officers,

Thank you to all who have responded to Carolyn Blanchard about the meeting next week. The deadline is not until tomorrow, but we have heard from every institution except: <u>LSUA, LSUS, LSUHSC-NO, SU Law, SUNO, GSU, NSULA, ULL, FTCC, and NWLTC</u>. Your attendance is not mandatory, but we will be discussing a number of issues important to the campuses and hope you are able to attend. Also, to plan for lunch, we do need to know whether to expect you, please.

The primary purpose of this meeting is to have a conversation with you about the Elevate Louisiana initiative, seeking your feedback and input about how the tasks might best be accomplished. Other topics that could be addressed would include dual enrollment, recent changes to AA 2.18 and the Admission Supplement, the AP and CLEP credit tables, transfer & articulation in general, an upcoming Board of Regents' Open Education Resources (OER) project, and the Louisiana Transfer Degree, as time permits.

To give you context and help you prepare for the meeting, I have attached several reference documents:

- The ELEVATE LOUISIANA: The New Realities document from the April BoR meeting
- The Undergraduate Degree and Graduate Degree CRINs with 3-year averages, arrayed by regions and annotated with LED workforce priority indicators. The CRINs are not exact matches to the current CRIN, as I tried to combine like-program titles and revisions to reflect 3-year average completers as accurately as possible. Most programs with '0' completers also have the approval year (e.g., 0-11) to put them in context.

One request to you is that you identify those programs or areas at the undergraduate and graduate level which are your institution's areas of strength or excellence, along with a brief paragraph explaining your reasoning for including the program on the list. [Limit to Top Five, total] You could send it ahead via email, bring it with you, or wait until after the meeting to send it, but we really would appreciate your input.

The *Role, Scope & Mission* section of the 2012 Master Plan. You can see that it is time for revisions if only to combine RSMs for institutions that have been merged since the last Master Plan revision. Our intent is to keep the same basic format.

Again: we do not have the answers about how the principles or parameters will be addressed, but we hope to have a better idea after this meeting with you. Thank you for coming.
